ANNUAL REPORT FOR THE YEAR 2018 – 2019

Dear Friends,

Another year passes and the excitement continues to build. We are on a growth spurt, not only geographically but also innovatively. As we look back at the year 2018-19, we find ourselves being more grounded, more articulate about our non-negotiables and more adaptive to external situations. It has been a year where we have achieved our targets amidst challenges. Responding to challenges has strengthened our resolve to respond to any situation and take it in our stride. This year has been a year of experimentation, learning and evolving for us. The year threw up many challenges, prompted us to push ourselves to new limits, become innovative and emerge with new insights. It made us face many situations where we were challenged to change, modify or recreate the modality to work with our beneficiaries. However, what did not change for us is our zeal to create a 'society based on the principle of equal, accessible and affordable education and health for all '. The path for this work has never been smooth, and we have faltered, learnt and evolved into being more rooted and compassionate. We are delighted to have exceeded our targets across all of our programmes. We have also strengthened and streamlined our interventions through regular monitoring, evaluation and timely strategic decision making throughout the organization. In times of crisis and pain, what motivated us to stay stable is the faith that has been bestowed on us by our beneficiaries, partners, funders, volunteers and well- wishers. Amidst all of this, we are kept motivated when we see little smile in the face of our beneficiaries. This year we were fortunate enough to see many such moments, and we would like to give you a glimpse of these through this annual report.

In the year 2018-19, Turnstone Global has been able to touch the lives of 69,432 individuals including 54,457children and rest adults. This takes Turnstone Global overall outreach to 11, 33,244 individuals directly, since inception and indirect outreach to over 46, 43,572 individuals. Our growth rate hit 11% this year.

We used a 'Bottoms up' and 'Top down' approach, taking inputs from all levels of staff, Trustees and external stakeholders to map our priorities and the roadmap to scale our work. We unanimously decided to focus on three areas:

- 1. To continue to create evidence based models on community based participatory approach to improve education and health indicators in the most vulnerable areas and marginalized communities;
- 2. To scale our impact through replication of these models, through other NGOs and the Government; and
- 3. To build our organization's capacity to support scaling through partnerships. The decision to scale our models through partnerships is a cost effective but bold measure, given the complexity of working in partnerships.

We initiated our first partnership this year with Atmik in Bandel, West Bengal, with our model on [education for the children of migrant worker] subsequently few more partnership models has increase our understanding of working with partners, different contexts, refining our

interventions and eventually leading to a cost effective way of increasing our footprint and scaling our work.

In this year, Turnstone Global has seen exponential growth. We have expanded our presence to many new states including Delhi, Bihar, Orissa and Rajasthan. We are developing new, innovative solutions to increase the impact of our work through programmes such as Umang, Udte Pankhe, Validations and more emphasis on skill development and livelihood generation. And finally, we strive to be completely transparent and have a clear-cut 5-year plan to reach as many beneficiaries as possible.

The role that the Partners play in these efforts deserves to be specially mentioned. We have for many years been working together with visionary CSR partners who have supported the projects. This year seven new partnerships were established in the CSR ambit, bringing the total number of CSR partners to 15. Additionally 32 other partners, state governments, banks and financial institutions, National foundations and organisations have supported the projects. The complete list of partners is included in the report. We are looking forward to continue to be partners in development and hope that we will be able to expand and increase the impact of the work in the years to come. I also want to thank our 124 employees who are the backbone of the organisations and who make the real changes in the field together with the people. The dedication, professionalism and passion of our employees are our greatest asset. Thank you also to the many who have been volunteering through Company employment engagement and in other ways and thank you to the many panchayats, local teachers, passionate and youths helping out many a time in the projects to overcome and organize day to day challenges, prepare community events, sharing knowledge and debating and much more. We are looking forward to continue the cooperation with all of you. We invite you to partner with us to ensure we expand our reach through the length and breadth of the country and even cross borders.

About us:

Turnstone Global — a not-for-profit voluntary Organisation — is engaged in providing Comprehensive Empowerment to underprivileged sections of the society. The Organisation firmly believes that a holistic approach is necessary to obtain overall development of the society. Hence, unlike most other NGOs, who work in specific fields, Turnstone Global provides a diverse range of services to its beneficiaries. Such services range from providing pre-natal health care to fostering old age care; covering in between sectors like education, healthcare, skill development training, livelihood and entrepreneurship development skill and so on. Therefore, the term "providing Comprehensive Empowerment" is used while describing activities and nature of Turnstone Global.

Ouite naturally, to achieve this stage of providing comprehensive empowerment, activities of Turnstone Global has grown into leaps and bounds. Starting with serving a handful of visually challenged beneficiaries form the backyard of a rented accommodation, today, the Organisation has its own infrastructure in providing services of diverse nature. Furthermore, Organisation has spread its wings not only in different locations of West Bengal, but also in several states of the country. Today, Turnstone Global works in 11 states of India. It is worth mentioning here that the Organisation's activities are not restricted to cities and towns but also spans different levels right till the grassroot level beneficiary living in rural panchayat areas. In West Bengal alone, the Organisation works in over 650 villages under 42 Gram Panchayats in 16 districts.

Turnstone Global plans its programmes and activities based on field level survey and in-depth analysis of data gathered from such surveys. Community members are consulted right from the conceptual phase of a programme. This approach ensures that programmes of the Organisation are community centric, based on actual ground level needs rather than being a top-down model.

Turnstone Global is duly registered under the West Bengal Societies Registration Act, 1961. The Organisation is also registered under sections 12A and 80G of the Income Tax Act 1961. It is also registered under FCRA. Transparency and maintenance of high standard in performance helped Turnstone Global achieve ISO 9001: 2008 Certification.

i. General Health

Turnstone Global is an NGO committed to providing Comprehensive Empowerment to the society, especially to our less privileged brothers and sisters. However, empowerment cannot be complete unless physical health of our fellow citizens is improved. Thus, whenever it comes to providing health care services, we take reference of the Greek philosophy "A healthy mind in a healthy body". Thus our health care services are provided keeping this Greek philosophy in our hear hearts.

Although we stress on providing services to persons for whom affording health care service is a dream, our field level work experience reveals that in number of cases, people having affordable capacity are severely affected with ailment which have gone undetected owing to lack of awareness. Thus, in addition to serving the underprivileged, our health care services are also extended to people belonging to every strata of the society.

Regular medical camps are organised not only in rural areas but also semi urban and urban areas of West Bengal including Kolkata – the State Capital. In addition, we have also started conducting health check-up camps in corporate sector. It is in this sector, we have detected several ailments which have gone unnoticed owing to lack of awareness.

In addition to Kolkata, districts of North and South 24 Parganas, Howrah, Hooghly, Bardhaman, Purulia, East and West Mednipur, Nadia. Malda, Darjeeling, and Cooch Behar are covered under this programme. Unfortunately, several districts still remains untouched. North and

Dinajpur, Jalpaiguri, BankuraMurshidabad are only to name a few. Reason being paucity of funds.

During the year 2018-2019, 253 4medical camps (general and specialised) were organised. Average patient turnout in a medical camp was around 175. In some cases, the figure crossed 200. In all 44,275 patients were served.

Our medical camps at Belabahal village in Purulia district and Matigara block in Darjeeling district have turned into functional OPDs. On every second Saturday of the month, team of doctors visit Belabahal to examine patients and prescribe treatment accordingly. At Matigara, OPD camps are held every Saturday. Average patient turn out here is approximately 230. At both these units, subsequent to examination, dedicated volunteers follow up with patients as recommended by our medical team with the objective of observing progress. They have clear instruction of reporting condition of patients to the doctors in case of any emergency. Much to our delight, such emergency has not occurred till date.

In view of the insufficient healthcare facilities available at Belabahal of Purulia, we have been receiving request from neighbouring villages to make this OPD functional on regular basis instead of during weekends only. They are also requesting us to extend facilities at patients door step since often they are unable to bring critical patients at the OPD. Hence, Turnstone Global is planning to begin a mobile OPD which will cover adjoining villages of Belabahal. This mobile OPD will be operated using a vehicle equipped with medical screening facilities accompanied with team of doctors and paramedical staff. However, this is at a conceptual stage. Implementation depends on availability of funds. The Organisation is also planning to establish an Eye Hospital in Belabahal village. Once, this is setup, the present OPD will function on all week days and surgical cases will be dealt in the hospital. However, this plan is subject to available of funds.

Some glimpses of our medical camps

On 25th March, 2019, a multidisciplinary health camp was organised at Nabadoot Sangha in Baranagar – Kolkata. Practicing professionals from fields of General Medicine, Ophthalmology and ENT screened over 300 patients at this camp. We have received request from local residents to hold camps like this on regular basis.

Among several health related programmes, organising medical check-up camps for children has been of special importance to us. Thus, we conduct health check-up camps in schools as well as out-of school. On 19th August, 2017 one such out-of-school camp was organised at Park Circus in Kolkata for out-of-school children.

At this camp, approximately 173 children were registered. Overall health conditions of children were satisfactory and their BMI was in proportion to their age. 5 children were detected to be suffering from fever, hence blood test was recommended for them.



On February 9th, 2019, Turnstone Global, led by Medical Director Dr. Satyam Dey, organised a medical camp at for employees of Jalan Distributors, a distributor of Maruti Udyog in Kolkata. Here, it was observed that most of the staff, especially the middle level managers and the ones in upper position suffer from stress and hypertension, which, if remains unchecked, might lead to severe problems later. Thus, those members of the staff were suggested to undergo

some sort of therapy that would ease their tension, like meditation, music therapy and so on.









Eradication of preventable blindness – Eye Care on Wheels

Our initiative to eradicate preventable blindness started from early 2012 when Cognizent Foundation extended their whole hearted support and provided sufficient infrastructure for the purpose.

Our Tata Winger, equipped with advanced eye testing equipment lead by a team of Ophthalmologist and duly supported optometrist travel to remote areas to conduct eye check-up camps. Main purpose of this mobile unit is **"To serve the unserved".** Patients detected to be suffering from cataract problems and requiring other surgical intervention are brought to Kolkata for respective surgeries. The ones identified to have refractive errors are prescribed accordingly. Wherever possible, based on availability of funds, free spectacles are distributed among patients.

In 2016-2017, the programme covered the districts of North & South 24 Parganas, Howrah, Hooghly, Burdwan, Purulia, East & West Mednipur, Murshidabad, extending up to as far as Coch Behar and Darjeeling districts.

Patients are identified through community camps, held at various locations. Community Based Organisations (CBOs) are mostly utilised for this purpose. In addition to holding community camps, school camps are also organised.

Patients obtaining benefits from this programme have been very responsive. Our tie up with Sankara Netralaya – Kolkata has been very acceptable to underprivileged patients.

Some glimpses of our eye check-up camps:

On August 19, 2018, an eye screening camp was held at Tiljala Shed, adjasccent to Park Circus Raiway Station.. About 124 patients were screened at this camp.



Most of these patients were identified to be suffering from refractive errors and were prescribed spectacles. Some patients were identified to be suffering from a particular type of infection in the eye. Those identified to be suffering from cataract were brought to Kolkata for surgeries.



Multidisciplinary therapeutic service under one roof

In its endeavour to provide therapeutic service to children, youth, adults and the elderly, Turnstone Global has been running a multidisciplinary therapeutic centre in Salt Lake since 2014. Services offered at this centre include Occupational Therapy, Vision Rehabilitation Therapy & Low Vision Equipment centre, Laser based and conventional Physiotherapy, Play Therapy, Dance Movement Therapy (D.M.T.) Psychological Counselling, Home Based Special Education for Children with Special Needs and similar other services. The unit also houses the first ever Internet De-addiction Centre in Eastern India.

Primary objective of this centre is to provide curative service to patients spanning a wide age group ranging from children to the elderly. No medicine is prescribed here because medicines only provide temporary cure as long as the medicines are advocated. Once the medicines are stopped, problems once again reoccur – although exceptions are there – hence the need to provide cure thru therapeutic service instead of advocating medicines.

First Internet de-addiction centre in Eastern India

Another important activity of the multidisciplinary therapeutic centre is providing curative service to internet addicts. Today, increase in usage of internet has provided us an easy access to information whenever necessary. The urban educated population cannot think about a life without a net-connection. The same however is having an adverse effect, especially among children in adolescence stage and teenagers. They are increasingly becoming "Netizens" and their attachment with social media and other forms of communications – commonly termed as "Free Social Networking Sites" and "Chat Sites" are becoming an addiction. This is not only affecting their mental growth, but is also making them isolated from social activities. It is worth mentioning here that Steven Jobs, the creator of I-Pad and I-Phone, himself prevented his children to access such devices. To cote him "We limit how much technology our kids use at home".

To combat this situation, Turnstone Global has been offering Internet de-addiction services. This centre is the first of its kind in Eastern India and the 4th one of its kind in the entire Subcontinent. Our purpose is to facilitate proper mental growth of adolescents and teenagers who are addicted to the NET and ensure that they grow up as good future citizens of the country.

Geriatric Care

- 4.Weekly check-up of vitals & PROVIDE BATTERY OPERATED BED SIDE BELL/TORCH.
- 5.Periodic bedside check-up BY QUALIFIED DOCTOR.
- 6. DAILY ASSISTANCE (SHOPPING/OUTING/TO INSIST IN SOCIAL INVOLVEMENT).
- 7. According to clients' need, provision of associates (granny-sitters) for companionship (DAY

AND/ NIGHT SHIFT), motivational therapy & supportive health care, both physical & psychological.

• 8. Renewal of old forgotten hobbies &provision

- of workshop on hobbies & exhibition of the products.
- 9. Cultural shows & film shows with prior booking.
- 10. Yoga & meditation therapy.
- 11. Community based theatre training & workshop.
- 12. Dance & movement therapy (both group & individual).
- 13. Group based personalised physical exercise session (stretching, strengthening & core exercise) with dietary & life style modification.

Much to our delight, 4th Dimension has successfully retained 100% of its patients who got themselves registered for the service. This, undoubtedly speaks about the quality of our service.




Albendazole and Vitamin A supplementation programme:

From 2014, Turnstone Global started implementing the WHO project of providing Vitamin A and Albendazole to children between the age group of 6 months to 59 months. Albendazole is provided to children within this age group as a de-worming process while vitamin A is provided to improve eye health, thus preventing occurrence of vision related problems from an early age.

This programme is globally implemented through "Vitamin Angles". It is indeed a matter of great honour for Turnstone Global to be a key implementing partner of Vitamin Angles for executing this programme in multiple states of India, ranging from Mizoram in the east to Punjab in the west. As on 31st March 2019, the programme served a total number of 3,98,000 children. Location wise details coverage is provided below.

In addition to serving children within the age group of 6 months to 59 months, Multivitamin tablets among pregnant women and lactating mothers were also distributed. Under this programme, a total of approximately served in the state of West Bengal. This is a very small achievement compared to our network spread wide across the country. Unfortunately, supply of Multivitamins were very less when compared to demand.

Blood donation camps:

There has always been a substantial gap between the demand and availability of blood at various blood banks in West Bengal. This scarcity intensifies during summer months. In view of this gap between demand and availability, Turnstone Global organises blood donation camps to reduce the scarcity.

On 15th August, 2018, one such blood donation camp was organised at Brojomani Debya Road, Kolkata. A local CBO named Udayan Sangha was chosen as partner for publicity and local arrangement. Ashok Blood Bank teamed up with us to collect blood from voluntary blood donors at this camp. A total of 194 donors voluntarily donated blood at this camp. As a token of appreciation, the donors were provided a small memento in addition to light refreshments. Subsequently, Ashok Blood Bank provided Donor Cards to all donors.



In all, 18 blood donation camps were organised in 2018 - 2019 in which a total 641 units of blood were collected.

HIV awareness camps

Despite efforts of Government, NGOs and other voluntary organisations, HIV is still considered to be a social curse. However, at Turnstone Global we think quite differently. We undertake extensive awareness campaign with the target group among whom such awareness is essential. Our target group are students of high schools, their guardians, truck drivers associations, sex workers and so on. We conducted awareness programme in the districts of i.e., Siliguri, Birbhum and Purulia in West Bengal.



At each of these places two days extensive seminars, discussions, debates, slide- presentation, stage acting, street shows, film shows were organised. We got a huge response from all target groups. We were successful in making people understand regarding infection of HIV, progression of the disease, mode of transmission, safety measures to opt for preventing the disease, after exposure necessary steps to be followed, boon of a healthy conjugal life and so on. At all of our three centres our community health workers follow up with the target groups on a weekly basis and also maintain a healthy liaison with all high risk target groups to prevent further unprotected exposure. We have a vision to eradicate HIV from the three districts of Siliguri, Birbhum and Purulia in West Bengal in the near future and to provide best care (medical, psychological, emotional) to the victims of AIDS in these areas.

Mother and Child Health:



The concept of healthy mother and healthy baby is an important aspect of reproductive health care programme. In a developing country like India, poverty, illiteracy and multiple pregnancies take their toll of mother's health and that of the breast-fed infant. High prevalence of anaemia and malnutrition among women in reproductive age group, particularly during pregnancy and lactation can have irrevocable effects on the infant's health.

Also in a country like ours, infections and ill health necessitate long term drug therapy of the mother even during lactation and it is well established that most of the drugs present in the maternal circulation get transferred to breast milk.

Delivering healthcare to over a billion people is a very complex challenge. But still this necessitated us to develop a project to help the mother and child. Turnstone Global works to secure accessible and quality maternal and child healthcare among marginalised communities. The Organisation works towards identifying the root causes of healthcare challenges, provide innovative solutions, and help implement secure and quality healthcare services in India.

The organisation aims at empowering every mother and her family belonging to a vulnerable community to make the right food choice by providing accurate actionable knowledge and other associated intensive services.

Through its projects, Turnstone Global focuses on encouraging preventive health, balanced nutrition and child developmental practices in underprivileged communities. To achieve this we adopt a holistic approach, by embracing, educating and empowering mothers and children in their social environment.

The objective is to address issues of status of women, the care of pregnant mothers and children under two, breastfeeding and the importance of balanced nutrition and health. The focus is on women between 13 and 35 years of age and their family members.

Turnstone Global believes that a healthy mother and a healthy baby is the route to a productive, developed nation. Hence, the organisation has specially focused upon providing comprehensive solutions to address public health problems



Day school at Purulia

In pursuit of providing quality education in rural areas and bridging the gap between INDIA and BHARAT, Turnstone Global opened a school in the remote village named Belabahal in Hura block of Purulia district. Initially this was a day school, however, from 16-17, the Organisation started providing residential facilities to students of this school.

This school named Daulat Public School presently serves 207 students of whom, 67 are boarders and the rest are day-scholars.

To ensure "QUALITY EDUCATION", trained and well experienced teachers are appointed for the purpose. Syllabus of the school is aligned with the prescribed syllabus of the CBSE so that when students complete their primary education and enter the secondary level, they will already be qualified enough to cope up with the CBSE syllabus. Additionally, the School also introduced syllabus in tune with the West Bengal Board, so that students who want to pursue Madhyamick level education will have the option open.

Apart from academic activities, annual sports, excursions and various other activities are also followed in the school calendar.



Non Formal School - Bashanti Colony

It is indeed a matter of great opportunity that for the fifth consecutive year we have been receiving support from the people of Bashanti Colony to run our non-formal school.



Bashanti Colony is a slum area adjacent to Bidhan Nagar railway station situated in the heart of Kolkata. During the initial stages, our volunteers had to knock every door of Bashanti Colony, urging parents that children should be send to school. Refusals were a common phenomenon during the initial years. Over the last four years, we have noticed a phenomenal change in mind-sets among guardians of Bashanti Colony. Today, it is those same Parents, who refused to have their children enrolled at our non-formal school, voluntarily send their second or third child when they grow up and attain school going age. This proves that people of Bashanti Colony have realised the importance of education to shape up their children's future.

Children within the age group of 4 to 16 are enrolled at this non-formal school. Children are segregated in three sections, depending on the age group they belong to. Children within the age 4 to 8 are placed in the first grade, the ones within 9 to 12 are in the second grade and those within 13 & 14 are in the third grade. Presently, 276 children are enrolled at this school. Classes are held from Mondays through Fridays from 2 p.m. to 6 p.m. It has been observed that children of Bashanti Colony often help their parents in work activities just to fetch a little bit of extra income. Male children assist their fathers as child labours while the girl child assist her mother who work as domestic aid. Hence we have selected the post afternoon slot as school timing. Till such time that we are able to augment the child worker's economic contribution to the family, we do not want to disrupt the family's income. Teaching methodology in this non-formal school is quite different than the one followed in regular schools. Thrust is given on two-way communication rather than the teacher making a one way communication with his or her students. This makes learning fun for the children.

Volunteers from various Universities as well as the Corporate sector visit this school to share their knowledge with the learners here. They provide basic computer knowledge, drawing lessons and so on. In addition, dance lessons are also provided to the children here on regular basis.



Working in the area for quite some time, we have noticed that children of this urban slum do not remain hungry. However, their diet is mostly rich in carbohydrate and lack protein. Hence, we provide nutritional tiffin rich in protein content to children attending the school. Perhaps this nutritional tiffin acts as an additional encouragement to attend school on regular basis.

In addition to providing nutritional tiffin on regular basis, often, with support from Spencer's Retail, food grains and other food items are also distributed among the children and their parents of this school.

On witnessing our efforts, GiveIndia has extended their cooperation to rise funds through their portal to support education for the children of this school.



Story of change

After much reluctance and persuasion by our volunteers working in the area, Puja's mother started sending her 6 years old daughter to our school. As the father abandoned the family, Puja's mother Nilu toils as a domestic aid to support herself and this little girl. Additionally, the mother also has to support Puja's grandparents, all these within a meagre earning of Rs. 2,000/- per month.

During morning hours, Puja accompanies her mother to assist her as domestic aid. According to the mother, she wants Puja to complete her education and take up some office job instead of becoming a domestic aid like her while Puja herself

wants to become a teacher, educating other girls of the area like her Teacher Didi.



Brick Field School


Brickfield workers and their families come to West Bengal mainly from neighbouring states of Chhattisgarh, Bihar, Jharkhand, and Odisha. At their place of origin these people mostly work as agricultural labour; the areas of their origin being not very fertile, there is only a single harvest in a year. Hence, augmentation of income needs is the primary reason for migration. They spend six to eight months (work starts from November and continues till June in the following year) in West Bengal working as labours in unorganised sectors mostly brick fields. They work as families / units. Their children mostly have never been to school and, stay inside a lifelong loop of vulnerability.

To provide education for such children, Turnstone Global has set-up schools in brick field areas of Bandel in Hooghly district of West Bengal. This is a collaborative effort between Turnstone Global and a local NGO of Bandel named ATHMIK. This intervention is a perfect model of collaboration for empowerment of underprivileged children where Turnstone Global is the lead organization responsible for resource mobilization and Athmik is the grassroots level organization responsible for implementing the project.



As mentioned earlier, children of migrant brickfield workers have no access to any

kind of education – this project is all about providing education to them. The majority of these children do not speak Bengali, and in West Bengal the medium of education / instruction in the Government schools is primarily Bengali. So there is no point in admitting these children in those schools; thus the intervention logic used for brick field schools is "Let's bring the schools to the children", and seasonal schools were opened inside the brickfields. The medium of instruction is Hindi. Although we believe teaching in mother tongue is best option for all children; however, in the rural areas of West Bengal teachers who can teach in languages like Bhojpuri, Mundari, Santhali, Oriya and Chhattisgarhi are difficult to find. Since all children speak and understand Hindi, we decided Hindi to be the medium of instruction for such Brick Field Schools (BFS).



Presently there are 5 BFS enrolling 250 students. Children in the age group of 4 to 14 years are enrolled at these BFS. Majority of the children are between the age group of 6 to 12 years, and they are segregated into 3 grades according to their age, Grade-I for 3 to 6 years, Grade-II for 7 to 10 years and Grade-III for children who are above 10 years old. The BFS follow a daily time schedule of 30 minutes x 5 periods covering the basic needs like:

EDUCATION

- Improvement of Language Skills
- Improvement of Number Skills
- Improvement of General Awareness'
- Improvement of Creative Skills
- Improvement of Physical Skills

We try to provide a compact package of education for these children, containing basic literacy, numeracy, creative and physical skills, and general awareness related materials, which will empower the children with some knowledge and basic skills.

- Literacy ability to read and write one's own name in Hindi/mother tongue and also the ability to handle small sentences
- Numeracy ability to count and to do addition-multiplication and subtraction-division in Hindi / mother tongue
- General Awareness'— about health and hygiene, nature and culture in Hindi/mother tongue
- Creative and Physical Skills ability to express oneself through stories, songs, dance, drawing and painting, clay modelling and to take part in sports and games.

For Suraj Das, happiness means —brick field school, Teacher Didi and his current home in the brick field. Living in the scenic backdrop of Bandel, in West Bengal his life isn't as easy as it might seem. To earn two-time meals, his parents work as daily wagers and hardly get time to look after him and his siblings. Being the eldest son, Suraj thus takes the whole responsibility of raising them with undivided love and care for them.

When Suraj first came to our brick field school he use to stay aloof and made minimum interaction in the class he did not show any interest in studies as well. But slowly with some extra effort from the teachers he has shown remarkable improvement. Now Suraj is among the regular students in the class and he takes initiatives to teach his small siblings also.

It wasn't difficult for us to sensitize and convince his parents to enrolling the children in our brick field school and they are eager to admit them in Government School when they go back to their village. They are glad to have taken this decision as their kids have developed keen interest in studies and extra-curricular activities.

Touch the Childhood

Touch the childhood is a school programme for children with learning difficulties ranging from Dyslexia to Dysgraphia and ADHD. With a low student/teacher ratio and educational programs designed to suit individual learning needs, touch the childhood creates a holistic learning environment in which children with learning difficulties can excel. Touch the childhood started in 2011. Children with learning difficulties are not underprivileged in the traditional sense of the term, but they are underserved; not given an equal opportunity to access quality educational offerings.

The programme focuses on creating and providing Quality Education for children withlearning difficulties.

Turnstone Global 2018-2019 Outcomes:

- 1. Continues with "Touch the Childhood" OUT-Reach Programme Guide to outline the reasoning, the need and the structure of the OUT-Reach Programme.
- 2. Facilitated the development of a centre having vision therapy unit.
- 3. Created marketing materials including a brochure and mailer to address the OUTReach Programmes
- 4. Developed a three level curriculum to be used in the OUTReach Programme to address the English deficit in students, and a matching manual to ease the teacher'sability to use the curriculum.
- 5. Developed a lesson plan template that will allow teachers to plan their programming more easily and document lessons for future use.
- 6. Formed a Steering Committee for the development of the OUTReach Programme.

"I've moved away from day to day thinking and I am focusing further down the line, setting new ones."

We are working on concrete goals and impactat one year or three years in the future. This "Touch the Childhood" programme has resulted in the formalisation of OUTreach:

A scalable arm of CHILD welfare offers remediation for children with learning difficulties in other schools. With the implementation of the Right to Education Act, replication of the OUTReach Programme is more important than ever as more students with learning difficulties will have to stay in mainstream schools and go even further in their academic careers before receiving access to appropriate learning assistance. The OUTReach Programme hopes to grow to reach more of these students.

Story of change:

Rakhohori is 14, and joined Touch the Childhood school three years ago. Since becoming a student at Touch the Childhood, Rakhohari has been able to excel in subjects that were previously inaccessible to him. This is because Touch the Childhood offers Rakhohari a classroom environment and specialised attention that supports his unique learning style.

Touch the Childhood aims to create an environment where students with learning difficulties can thrive, by challenging the unique abilities of each child. Occupying a room of our school at Purulia, Touch the Childhood school has been since June 2013.Rakhohari attended two different schools before hearing about Touch the Childhood. In his previous schools, Rakhohari lost confidence because he was not given appropriate time to answer questions he

was asked. Rakhohari has Attention Deficit Disorder and has trouble forming his sentences because of poor short-term memory. He needs a little bit more time to effectively communicate, but is otherwise not limited in his capacity for learning.

At Touch the Childhood, children attend classes of different levels for each individual subject, depending on their ability. When children do not have to study all subjects at the same level, they're able to excel in their areas of strength without being held back. The Touch the Childhood teachers support each student in their specific learning style and challenge them as they need. "Rakhohari is a proactive student and a very keen learner. We give him the space to develop at his own level in each subject, and we're glad to see how much he has grown," said RakeshMahato, our mentor at Touch the Childhood.

Scholarships

To promote education among the underprivileged, including the differently abled, Turnstone Global offers educational scholarships both at school and college level students.

Selection for scholarships are made from applications received. Merit of the student and economic condition of his or her family is considered while approving scholarship to the student.

Scholarships are segregated in two levels. The first level is Scholarship for school students, which is given to underprivileged students studying from class VI to class XII. The scholarship amount is Rs. 300/- per month. School students use this amount mainly to support tuition fees. Sometimes they also use this amount to buy reference books. As on 31st March 2018, 341 school students studying between class VI and Class XII are given scholarship of Rs. 300/-each.

The second level of scholarships is given to students undergoing higher education at college or university level. In this case, selection is made from the student's performance in 12th standard Board Examination or performance at the Graduation level, whichever the case may be. In addition to performance, economic background of the student's family is also given due consideration. Scholarship amount at this level is Rs. 500/- per month. As on 31st March 2017, 152 students undergoing education at graduation and post-graduate level are being provided a scholarship of Rs. 500/- each per month.

Story of Change – the Story of Priyanka Das



Priyanka was a student at our non-formal school since the age of 7. Her father is a van puller while her mother works as a domestic aid in the hi-rise apartments around Bidhan Nagar area. During morning hours Priyanka used to assists her mother in domestic chore and comes to this school during the afternoon. Her parents always wanted Priyanka to be educated and secure a job in an office, unfortunately their meager income could not afford education for this bright child. Right from the beginning, Priyanka had been a good learner. After completing grade IV, Priyanka was able to secure admission in a Government school. However, marginal income of the family prevented Priyanka from going to school. When she was promoted to Class-VI, our scholarship programme for school

students enabled Priyanka to continue her studies. With this scholarship amount of Rs. 300/-per month, today, Priyanka can complete her education up to 12th standard. Priyanka dreams of becoming a graduate and secure a job after which she will prevent her mother to work as a domestic aid.

Vocational Training and Placement Programmes

With support from Amway Opportunity Foundation, Turnstone Global has been offering vocational training to the youth for quite some time. The vocational training centre is situated at Rafi Ahmed Kidwai Road and is named AOF Centre of Excellence as a mark of gratitude towards Amway Opportunity Foundation. This centre specialise in providing vocational training to mostly persons with disability, especially the visually challenged. Youth from economically backward communities are also enrolled at this training centre.

As part of its vocational training, the following courses are offered:

- i) STVT on Computer Fundamentals
- ii) STVT on Travel and Tourism
- iii) Soft Skills, Personality Development and Spoken English
- iv) Handicraft and Paper Craft Making
- v) Music Training





Apart from providing vocational training, the AOF Centre of Excellence also offers career counselling to the trainees. This vocational training unit is strongly backed by a Placement Assistance Cell whose role will be discussed in details later.

Methodology practiced in providing Vocational Training

The youth seek vocational training with a prime purpose of getting an employment. However, mere training in specific field and subject knowledge alone does not guarantee a job. In addition to training in specific field and subject knowledge, it is essential to provide inputs which help in overall development of the individual's capacity and personality. Communication skills, presentation of the self, presence of mind, awareness of current issues and various other factors are keys to securing employment in today's Corporate India.

Thus, Turnstone Global designs it training curriculum which not only provide subject knowledge but also refines the trainees in terms of communication skills and personality development. Special thrust is given to develop communication skills in English as English is the primary language used in Corporate India. Apart from regular theoretical and practical sessions, interactive workshops are also organised for trainees. Inputs are also provided on mastering interview sessions. Mock interviews, group discussions and wherever applicable field visits are part of the training curriculum.

i) STVT on Computer Fundamentals

With support from Amway Opportunity Foundation, the Organisation has been running a short term Vocational Training (STVT) course on Computer Fundamentals since 2009. The course is duly affiliated to the West Bengal Council of Technical Education.

Duration of the course is 6 months. 2 batches begin in one calendar year, one in January and another in July. In the year 2018-2019, a total of 41 beneficiaries were covered under this programme. As on 31st March 2019, the 14th batch successfully passed out the Council examination and the 15th batch started its classes from January 2019.

The modules of the course are well designed emphasising on theoretical knowledge as well as hands-on practice for the learners. In addition to providing subject related inputs to the trainees, we also provide inputs to enhance their communication skills, spoken English, interpersonal skills and overall personality development to prepare them for Corporate India. The learners are also subjected to face mock interview sessions so that they can face job interviews with greater confidence and higher degree of efficiency. After six months of rigorous training, the students appear for practical and theoretical examination conducted by West Bengal Council of Technical Education. Some students have passed out with flying colours. Starting from the first batch, till date, 384 students have successfully completed this STVT on Computer Fundamentals. Faculty engaged in this activity are sent for refresher training so that they remain well informed about technological changes and up-coming trends in IT and IT enabled industry. Thus, they are able to impart this

knowledge about technological upgradation and up-coming trends to the students as well.

STVT on Travel and Tourism

Success in providing computer education to its beneficiaries gave Turnstone Global enough confidence to begin another course to broaden career opportunities for the youth beneficiaries.



With this objective at heart, the Organisation confidently started another Short Term Vocational Training (STVT) course on Travel and Tourism from June 2011.

Tourism being a sunshine industry in the country, especially in West Bengal, employment opportunity in this sector is on the rise. Thus Turnstone Global chose to prepare its youth beneficiaries so that they can fulfil their career objectives in this travel and tourism industry. Hence began this STVT on Travel and Tourism from June 2011 with support from Amway Opportunity Foundation. This course is also affiliated to the West Bengal Council of Technical Education. Duration of this Short Term Vocational Training course is six months. Batches commence twice a year i.e. in the months of January

Skill Development and livelihood Initiatives by Turnstone Global

Our decade's long experience in training management, Skill Development women empowerment and livelihood Management along with facilitation and training of Self-Help Groups (SHG) has earned appreciation from assessment agencies, renowned corporate houses and the Government departments. As of now more than 6000 (among which more than 1500 are persons with disabilities and 300 are transgender) trained till date in IT, Tour and Travel management, Handicraft, Candle making, Hospitality, Retail, Beautician sectors and partnering with West Bengal State council of Technical Education, Paschim Banga Soceity for Skill Development (PBSSD), Nehru Yuva Kendra, Britti Prosikhan etc. in the state of West Bengal, Odisha, Tripura and Jammu & Kashmir and other part of India.

Till date we have conducted training more than 6000 candidates and the training of another 3000 candidates are ongoing with different Government and Corporates.

Below are some major Skill Development Initiatives by Turnstone Global:

STVT(Short Term Vocational Training): Turnstone Global has a partnership with the department of West Bengal State Council of Technical Education to provide short term vocational training to the marginalized youth of West Bengal since 2013 and till date more than 1000 candidates have been successfully completed the training.

Nehru Yava Kendra:Under this scheme of Ministry of Youth Affairs and Sports, Govt. of India, we have conducted vocational training in IT-ITes, Retail Management, Beauty & Wellness and Tourism &Hospitality and under the scheme till date more than 1000 candidates have been trained in the same trades.

PaschimBangaSociety (Utkarsha Bangla) for Skill Development (PBSSD):Turnstone Global is an empaneled Skill Training Provider of PaschimBanga Society for Skill Development (PBSSD), Department of Technical Education and Skill Development, Government of West Bengal. Under the project of Utkarsha Bangla, PBSSD, Turnstone Global is implementing skill training to 2500 youths of West Bengal those are marginalized, school dropouts and unemployed.

Though we commit to provide 70% placement of our students but our target is to place 100% employment to the successor.

In the past we have placed our candidates in multiple sectors and the companies like HDFC Bank, Woodland Hospital, Aditya Birla, Club Mahindra, Cognizant etc. Our corporate funding partners like TCS, Airtel, On Process, Dabur, Amay are ready to hire the candidates from us. Apart from that various LOIs with multiple companies have been signed up to place our trainees.

Self Help Group:

So forth created 26 SHGs for the promotion of their livelihood generation.

Microfinance:

Turnstone Global recently started its wing of microfinance to support urban women for their livelihood generation through self-employment.

Promotion of rural artisans:

Water Hyacinth products, Jute products, Terracotta products, Handcraft by waste paper products.

Transgender:

For the welfare of transgender community through skill development and livelihoodgeneration we have dedicated wing for transgender people in the name of Manobi.

- a. Entrepreneurship Development for 2400 candidates in Purulia under SVEP scheme of MORD.
- b. Skilling of 700 candidates in rural part of West Bengal under the CSR of HSBC Skill for life project.
- c. Skilling of 500 candidates who are flood affected in Jammu & Kashmir.

Apart from that we are extending our skill development activities in Jharkhand, Bihar, Assam and Manipur.

Turnstone Global is providing skill development tomarginalisedyouthsof West Bengal and working for sustainable livelihoods by providing handholding support through employment generation.



Digital Literacy

The 21st century is rapidly becoming more dependent on computer with development of newer information and communication technologies (ICT). Digital systems are creeping into our daily routine replacing traditional ones, sometimes even making the traditional ones obsolete. To keep pace with this rapid change and make the country's youth ready for tomorrow, it is essential to make them digital literates.

Digital literacy in some form is present among urban youths in India. Unfortunately, in rural and semi urban areas, the scenario is quite disheartening. While computer literacy rate in urban areas is estimated to be as low as 6.15%, in rural areas, the figure is estimated to be below 4%. Unless this literacy rate is significantly improved in urban areas and the gap between urban and rural areas is reduced, the nation cannot harvest the benefits of the boom in IT sector.

To increase the rate of computer literacy and also to curb the gap between urban and rural youths, Turnstone Global launched has been running an unique programme of what it calls to be Digital Literacy Programme. This programme not only aims to make the youth familiar with computers and some of its basic usage, but also includes other digital devices like e- books and smart phones. Thus, instead of using the term "Computer Literacy" we have named this Digital Literacy Programme. The course is being run in tune with Government of India's National Digital Literacy Mission (NDLM).



This programme has been running simultaneously from Barrackpore (Kolkata), Belabahol (Purulia), English Bazaar (Malda) and Matigara (Siliguri). At all places, a senior faculty assisted by a junior faculty conducts classes for youth groups. Some special slots are also made available for housewives. Centre wise enrolment figure as on 31st March, 2018 is mentioned below.

- ➤ Barrackpore (Kolkata) 204
- ➤ Belabahol (Purulia) 431
- ➤ Matigara (Siliguri) 356

These figures depict how well the programme has been accepted by the youth at all locations. It is remarkably observed that enrolment in rural areas is higher than semi urban areas. This is mainly due to lack of opportunity of such learning facilities in rural India.

Incubating Women Social Entrepreneurs through formation of Self-Help Groups and Micro financing – Project "UDTHEPANKH"

Our experience in working with women, both in urban and rural areas, has made us aware of the fact that economic independence of women is an important factor to place them on equal footing with their male counterparts. It is primarily owing to their economic dependency, women are often deprived of their basic rights.

With an endeavour to provide economic independence to women, Turnstone Global started Project "UDTHEPANKH" – formation and training of Self-Help Groups (SHG) and, Microfinance; 2 areas of women empowerment that are intertwined. Our intervention in these two areas is aimed at creating sustainable livelihood for underprivileged women turning them into decision makers to promote women and girls rights within the family. This not only creates livelihood among women but in the long run, also prevent violence against women and girls within the family. Our long term goal is to create a fund for women empowerment and opening a cooperative society to support micro level women entrepreneurs. At present Turnstone Global provides loans at very low rate of interest for business enhancement to underprivileged women. As on 31st March, 2019, 500 women organised into 50 SHG units are benefited under these 2 interventions.



Project "UDTHEPANKH" is spread across the districts of North 24 Parganas, Purulia, Kolkata and Siliguri. Women covered under this project are not only provided economic assistance, but also given inputs in the fields of skill development, entrepreneurship development, marketing skills and last but not the least, book keeping. Turnstone Global also buy back some items manufactured by these SHGs and market them in selected locations.

The programme has received wide spread acceptance among women groups, as a result of which, requests for assistance keep pouring in.

Story of Change – The story of Sankari Biswas and her group

"We needed a small loan of Rs. 1,00,000, but it was very difficult for us to get even such a small amount." – This is a very common problem for small-scale entrepreneurs like Ms. Sankari Biswas and other members of her group, who are engaged in a business making Ladies Garments.

They need loan for business enhancement but find it very difficult to get that support from financial institutions; additionally if they take loans from private money lenders, they are charged a very high rate of interest.

Turnstone Global started an intervention to address this problem. Women groups were formed and, each group member becomes guarantor for other members of the group.



The group received loan from Turnstone Global at a very low rate of interest and, then the group distributed the loan amount equally among each member. With this amount, the group procured sewing machines and raw materials and started the business. After an initial gestation period, the group leader started collecting the weekly repayments and submits it to Turnstone Global.

Apart from solving financial problems of women entrepreneurs, this methodology also created bond among them, which will remain with them forever.

The Braille Press

With support from Cognizent Foundation, the CSR division of Cognizent Technology Solutions, India's one of the leading IT giants, Turnstone Global setup its Braille Press unit in 2009. Since then, this unit has helped the Organisation play a leading role towards popularising Braille at all levels.



This Braille Press Unit made it possible for Turnstone Global to setup the Braille Library at the University of Calcutta. The unit also made substantial contribution towards establishment of Braille and Physically Challenged Corners at Birchandra State Central Library – Agartala and other district public libraries in the state of Tripura. In addition to this, the Braille press made significant contribution towards setting up Braille libraries at Bhubaneswar, Kolkata, Siliguri and Aizwal.

Take-over of the Braille publication division of WebelMediatronics added wings to the Braille Press Unit of Turnstone Global. This take-over made it possible to increase the Braille production capacity. On an average, this unit has been publishing more than 250 new titles every year. In 2017 - 2018, this unit added another 253 new titles.

Braille and Audio Digital Library

Ever since its establishment in 2009, the Braille and Audio Digital Library at the University of Calcutta has undergone major transformations. Keeping in tune with rapid technological advancements, especially in the field of digital audio, this is inevitable. To fulfil the growing demands of patrons, the stock of Braille titles and Digital Audio titles are constantly increased.





This library houses the works of Sir Arthur Conan Doyle, Agatha Christie, Rudyard Kipling and numerous other authors. It is thru this library that works of Swami Vivekananda, Rabindranath Tagore, William Shakespeare and many other timeless works which have been made accessible to the Visually Impaired community.

Time and again, inspection of this library has been carried out by NAAC and UGC authorities who have appreciated the amazing work done by us. Delegates from foreign countries like Bangladesh, Malaysia and even far off Spain have visited this library and expressed their positive views.

Starting in 2009 with a stock of 250 Braille and 100 Digital Audio titles, the stock as on 31st March 2019 is approximately 1,471 Braille and 869 digital audio books. This library also houses a small recording studio where most of the audio digital books are created. To make recording hassle free, upgraded versions of softwares like AMIS, OBI, SOUND FORGE and DAISY are being introduced here.

In the year 2018 - 2019:

- ➤ 253 Braille books have been added to the collection
- ➤ 194 Digital Audio books have been added to the collection

Free hostel facilities for the Visually Impaired

Over the years, the organisation has noticed that students, especially the Visually Challenged, who come to cities from several Districts and remote areas, in quest for education, are faced with yet another challenge of finding a suitable accommodation for themselves. In view of this problem, Turnstone Global offers free-of-cost hostel facility to Visually Challenged students coming for higher education from remote areas.



At the moment, the Organisation provided such facilities at Matigara – Siliguri, where Visually Impaired students from different districts of West Bengal are accommodated. At the hostel in Matigara – Siliguri, it is seen that students not only from West Bengal but also other states like Sikkim approach for accommodation.

Students at this hostel are provided free accommodation along with free food facilities. At present, 51 students are residing at the hostel in Matigara – Siliguri.

Disable friendly old age home at Siliguri

In view of insufficient facilities for the disabled elderly population and the situation faced by such persons even at their own homes, Turnstone Global planed to setup a disabled-friendly old age home at our unit in Matigara, Siliguri – name of the unit being Matrimandir. Work in this respect started in 2012-2013 and we had promised to complete the work by 2017-2018. A promise is a promise. We are happy to share the news that "Matrimandir" is ready in all aspects. Inauguration of the unit and welcoming the first resident in only a matter of time. Applications for accommodation have started pouring in from different parts of West Bengal.

Distribution of accessible equipment

Our quest to support persons with disability and make them self-reliant requires providing such persons with assistive devices. These devices help them to adjust their life style and lead their file in a more fulfilling way.

For example, CD Players, MP3 Players and similar devices are provided to print impaired students in order to gain access to Digital Audio Books – a must for their studies. A more traditional device like the white cane is provided to the 100% Visually Challenged. However, this White Cane is being fast replaced by the "Smart Cane". The Smart Cane has got in-built electronic sensors which can detect obstacles from a distance and send warning signals to the user in advance.

Support is also provided to orthopedically challenged persons by providing wheel chairs, crutches, etc. Turnstone Global is trying out to establish a working relationship with ALIMCO – a mini NAVARATNA Company – to provide artificial limbs to persons requiring such support.

Hearing Aid for the hearing impaired:

From 2012 - 2013, Turnstone Global started providing Hearing Aids to persons suffering from Hearing Impairment whose hearing can improve with a Hearing Aid. Initially, the Organisation used to run this programme from its corpus fund. However, in 2012 - 2013, Give India acknowledged our efforts and from 2013 - 2014 started extending their support towards this programme by raising online donations on their portal exclusively for this programme.

In 2018 - 2019, Give India supported our Organisation to purchase 65 hearing aids, each costing Rs. 2,700/-. These hearing aids were distributed among beneficiaries mostly the elderly.

Story of change:

67 years old Gobinda Karmakar is economically dependent on his daughter-in-law after his son passed away in a



cerebral attack years back. The daughter-in-law gives tuition to kids, managing to earn Rs. 4000/- in a month. This is the only income for the family of 4. Thus, insufficient income led to negligence of healthcare. A well wisher brought Gobinda to our health camp at A. P. C. Blind School, Nabadwip where after Audiogram test, he was detected to be suffering from Bilateral SNHL. It was your support which enabled Gobinda to receive a Hearing Aid.








Project WASH

Safe drinking water:



Despite 70 years of Independence, availability of safe drinking water is still a distant dream in rural India. Thus water bourn diseases leading to ill health is very common in rural India. Turnstone Global, with its limited resources, has made a tiny effort to eradicate this problem.

In the year 2018-2019, Turnstone Global has made arrangement of portable drinking drinking water in several villages. Apart from this, the Organisation has also installed 10 tube-wells in several villages of West Bengal.





Evaluating projects as Third Party Evaluator - a step towards sharing knowledge and expertise

Turnstone Global has vast expertise in developing, implementing and evaluating projects undertaken by them. Backed by this experience and expertise, Turnstone Global embarked into yet another venture of evaluating projects executed by other organisations as Third Party External Evaluating Agency. The purpose was not only to share our own knowledge and expertise but also to witness process of implementation by other NGOs. According to our belief, this endeavour will provide Turnstone Global and opportunity to witness newer and innovative project implementation process across a wide spectrum – thus enriching our own knowledge.

As Third Party Evaluator, Turnstone Global has been fortunate enough to work on projects of different magnitude spread across a diverse geographical area. Till 31st March, 2019, Turnstone Global has conducted assessments in 10 states of India:

- Eastern and North Eastern States: Assam, Tripura, West Bengal, Bihar, Jharkhand and Odisha
- Northern States: Uttar Pradesh and Delhi
- Western States: Punjab and Rajasthan

> Some of our works:

- Rotary India Literacy Mission (RILM): Evaluation of child development project implemented by RILM in different parts of India through local NGOs. In this regard, so far the organization has evaluated projects in West Bengal, Uttar Pradesh, Rajasthan, Punjab, Odisha and Delhi. Till date we have evaluated 10 NGOs covering 8,800 children. The main finding is majority of these children are from families where the adults are unable to support the education of their kids, as result they dropout from schools. Thus only an outside effort can make the needed changes in lives of these children and one such big change is bringing them back to schools.
- UNDP / Catalyst Management Services Pvt. Ltd. (CMS): Research work conducted for gap assessment of Pradhan Mantri Awas Yojana Gramin (PMAY- G) scheme in Assam. The assessment was about taking feedbacks about the scheme and, the process of its implementation from Government Officials and direct beneficiaries in these districts, Kamrup, Cachar and Dima Hasao. The main findings are, according the geography of the area the design of houses under PMAY-G needs modifications, thus the state Government must be given the authority to modify design of houses.
- Child In Need Institute (CINI): Quantitative Assessment of Reproductive Child Health (RCH) intervention for safe child and motherhood in the project on 1,000 days approach. The intervention was in Urban Slums ok Kolkata area in 7 wards under Borough VI of the Kolkata Municipal Corporation. The total sample sizes of mothers were 110 and children being 200. The findings show that among the target population the tendency regarding health seeking behaviour has made a significant change and,

beneficiaries are now more prone towards taking proper treatment from Government Hospitals.

• Uttar Rajasthan Milk Union Limited (URMUL): An evaluation of the Swach Bharat Project jointly conducted with URMUL and Turnstone Global in the districts of Bankura, Purulia, Uttar Dinajpur and Siliguri on behalf of the Central Government. The evaluating was conducted through Focused Group Discussion with Asha workers and students of government schools on the awareness and advocacy of menstruation hygiene as well as usage of Indian House Hold Latrines built in the district. On basis of our evaluation the district was declared as Open Defecation Free District by the Government of India.

Work on Women Rights

Despite years of efforts to fight for equality, women are still exploited in various forms and are treated to be someone less capable than men. Gender inequality is present in both urban and rural India. In rural areas, the scenario is even worse; where women are deprived from their right to property, livelihood even identity. Domestic violence on women has become a regular headline in daily newspapers.

Turnstone Global engages itself in addressing these issues in a structured and systematic manner. In addition to our movements ranging from rights of persons with disability and other vulnerable sections, our specific focus has been addressing violence against women, their right to property and establish their leadership in society.

As crime against women is rising drastically, Turnstone Global organised mega rallies in various districts of West Bengal where hundreds of women participated. Meetings with women's groups were held to make them aware of their legal rights. Special thrust was given



to the issue of "Security of women in public places". Rallies, seminars, workshops, community mobilisation programmes and also distribution of leaflets were undertaken to spread awareness among women.

International

Women's day was celebrated at on 8th March at various locations. In Kolkata, seminar was organised in with collaboration Siksha Aiyatan College to mark the day. Several renowned women from different walks of life. including our Secretary Dr. Kanchan Gaba delivered their lectures at the seminar.

From our centres at Siliguri


and Purulia, a door-to-door campaign was undertakenby our womenfolk to educate every household on Women's rights.

In all:

- ➤ 15,132 women participated in mega rallies held thru out the year
- ➤ 37 schools and colleges were shortlisted to organise seminars and workshops on women's rights.
- About 15,928 students, mostly girls, participated in such seminars and workshops
- ➤ 1,847 households were touched thru door-to-door campaign on International Women's Day

Through our experience, gathered over a period of time, we have realised the need to economically empower the women, especially in semi urban and rural areas to be treated on

an equal footing with their male counterparts. This realisation has led us towards formation of self-help groups in semi urban and rural areas as an effort to economically empower women. As discussed earlier, in this quest to empower women, Turnstone Global launched project ""UDTHEPANKH", a project aimed for Incubating Women Social Entrepreneurs through formation of Self-Help Groups and Micro financing, thus making them self-reliant and economically independent. Decreasing violence against women was an additional achievement of this project.



A special mention should be made here that the District Family Welfare Bereau – Kolkata of the Government of West Bengal invited Turnstone Global to organise a sensitization meeting on Save the girl child campaign under PCPNDT among College Students. We were also requested to give priority to girl students in colleges. Arrangements were made accordingly. A workshop was arranged to comply the request.

Awareness and Advocacy

With a paradigm shift of focus from serving only the Visually Impaired to include persons with other types of disability; the underprivileged; irrespective of age, gender, cast and religion, Turnstone Global's commitment to advocacy aims at making a difference in the lives of all categories of persons. The Organisation has initiated several measures to convince the community at large, which include:

Equal treatment for the disabled and so called non-disabled community

Turnstone Global is committed to addressing the inequalities faced by Person with disability. We are working a strategy which aims to affect long-term social change at various levels, including increasing community awareness and participation of the disabled at various levels, influencing law and policy making and improving the government response, to increase awareness about Disability as a 'unique' diversity of mankind. Throughout the year, we organised various seminars and workshops for teachers and families of persons with disability and underprivileged, adult-blind, and representatives of government agencies, NGOs, media and other concerned target groups. In such gatherings the organization focused on building capacities to improve quality of disability services, facilitating inclusion of persons with disability in the society and recognition of rights of persons with disability in the society at large. Besides, other advocacy tools like poster campaigns, self-advocacy by people with disabilities. Information related to facilities, schemes & programs of Govt/NGOs for disabled persons were made available to 21 individuals. Information and guidance were also provided through postal services, internet & through website.



To sensitize the Students and make them aware about the rights of persons with disability, interactive programmes were conducted at different schools. Children along with teachers and guardians were invited to participate in the interactive programmes. On an average, two such programmes are held every month.

Number of district and state level initiatives were organised in Birbhum and Purulia with an aim to make local government, service providers and organisations aware and accountable for the issue of disability.

- As per provisions of the Right to Information Act and recommendations of high level committee setup by the Government to of West Bengal to enhance the school level education system for the disabled and make education inclusive, the Organisation undertook necessary follow-ups with different departments and levels including the Education Ministry to enquire about the progress made in this field.
- A year-long unique form of creating awareness on issues like healthcare, education especially education for the girl child, disability, were taken up by the Organisation in the districts of Birbhum and Purulia. During week-ends, street plays and dance actions addressing these issues were performed. Every week, a new spot was identified with the help of local volunteers who also undertook the responsibility of spreading the news of time and venue of the programme.

Dengue:

Dengue broke almost into an epidemic in Kolkata and several other districts of West Bengal. It was identified that lack of awareness about the Dengue among the common people was one of the primary causes which triggered off the rapid spread of the disease. Thus once again, Turnstone Global volunteered an awareness generation programme about Dengue.

Several workshops were organised to spread awareness about prevention of Dengue were organised. Emphasis were also made about precautions to be taken.



This awareness generation programme was undertaken in the districts of North & South 24 Parganas, Kolkata, Howrah, Hooghly, Burdwan, East and West Mednipur. At each place, a one day orientation programme was conducted involving staff and family members of Tata Motors sales and service network, local residents in and around the area, members and officials from local Panchayats or Municipal Corporations and other members from the local community. With the help of posters, slide shows and other forms of pictorial representation, causes and carriers of Dengue, symptoms of the disease, DOs and DON'Ts were explained in details to members at the gathering, besides covering these topics, other general information about Dengue were also provided to the participants of the workshop. At every place, some participants of the workshop were selected to form a group who would voluntarily contribute in spreading awareness about Dengue in their localities.

Awareness on ecological imbalance and Climate Change

Affecting ecological imbalance owing to expansion of housing projects in urban areas in not a new phenomenon. Factors like felling of trees, filling of water bodies is a major cause of such imbalance.



However, growing demands of housing needs in urban areas cannot be also stopped. To maintain a balance between the two and also to create awareness on this issue, like every year, Turnstone Global celebrated six-day long Bon Mahotsav simultaneously at Kolkata and Belabahol in Purulia from 14th July to 20th July, 2018. In Kolkata, stress was given on urban forestry. In addition, nature study camps were also organised Purpose was to draw attention of the youth towards effects of deforestation on our ecology and thus make them aware about the need of urban forestry. At Belabahol, more than 500 saplings were planted with support from the district forest department. Local inhabitants from neighbouring villages willingly participated in this Bon Mahotsav programme.

Ecological imbalance is directly affecting Climate change. Today this is a burning issues having a

widespread impact on lives both human and wild life. Hence with support from District Forest Department of Purulia in West Bengal, a campaign was launched in Hura block to make tribal families aware about issues related to climate change and its effect on their lives. The children were made ambassadors to spread the key messages on importance of forest and water bodies in the life of forest dependent families among. A weeklong campaign accompanied with competition was organized with the help of Panchayats and local voluntary resource persons from the block itself. All together 1428 children were involved in this campaign and 10,000 trees were planted at the block itself.

Rights of the Consumer

With a paradigm shift from serving only a hand full of visually challenged beneficiaries to overall development of our society three years back, Turnstone Global has been playing a major role in creating awareness about a wide range of issues.

Among various issues, Turnstone Global feels that in a country like ours', consumers, in general, are quite unaware of their rights, thus they are often misled, which sometimes put them in serious difficult situations. When such situations arise, the consumer feels helpless and remains in a hopeless situation.

To combat situations like these, the Government has launched a massive campaign. However, it is the responsibility of organisations like Turnstone Global to augment the Government's effort and come forward to spread awareness among the consumers about their rights and especially where to seek assistance when their rights are ignored. With this view, Turnstone Global has been undertaking several Consumer Awareness Programmes since 2013-2014 which still continues till date.

With limited resources, this Consumer Awareness Programme has been restricted to the districts of Purulia, Malda, Kolkata and Suliguri subdivision of Darjeeling district. While most organisations stress on state capitals or district headquarters, Turnstone Global has targeted urban as well as rural areas in districts mentioned above. Year round meetings and seminars have been conducted in various places throughout the districts targeted. Legal experts on Consumer Protection Act were invited to address gatherings at seminars and meetings. Topics ranging from consumer of products to consumer of services and other similar spheres were included. In addition to meetings and seminars, short plays were enacted covering topics related to consumer awareness.

In the year 2018–2019:

- ➤ 4 districts were covered
- ➤ 18 meetings and seminars accompanied by short plays were held at different locations
- Approximately 18,054 consumers participated in the programme.

Witnessing our efforts in spreading awareness among the consumers, the Department of Consumer Affairs – Government of West Bengal has authorised Turnstone Global two permanent Consumer Assistance Kiosks in Kolkata, one at Nelli Sengupta Sarani and the o other at Kolkata Alipore area.

BIRTH ANNIVERSARY OF HELLEN KELLER – 27TH JUNE, 2018.

On 27th June, 2018, Turnstone Global in collaboration with Amway Opportunity Foundation celebrated the Birth Anniversary of Helen Keller. The programme started with a welcome speech By Dr. Kanchan Gaba – Secretary, Turnstone Global. Speaking on the occasion, Dr. Gaba highlighted the life and works of Helen Keller, the lady with a remarkable edge of mind. Later the picture of Helen Keller was garlanded by the dignitaries present on this occasion.

One of our blind beneficiaries presented a lively Tagore song to the audience. Several dignitaries from Amway Opportunity Foundation were present at the occasion. Later three sighted and three sightless persons participated in an extempore competition where they were asked to speak on different pertinent issues within 2 minutes. The programme was a huge success. The programme ended with distribution of certificates and gifts to the participants. Many important and unknown facts about Helen Keller were revealed in the speeches delivered by the dignitaries.

Matrichhaya celebrates Rabindra Jayanti

On 9th June 2018, resident of Matrichhaya celebrated birthday of Gurudev Rabindra Nath Tagore. In the morning, music teacher of Matrichhaya Manik Ghosh led the residents to the



function hall where they sang a Tagore song in Corus formation. After the song, one of the boys named Abhijit Saha recited a poem of Gurudev. An audience of about 65 were present in the hall. After Abhijit's recitation, This effort of the sightless boys was well appreciated by the audience present at the hall.

Celebration of Independence Day

On 15th August 2018, children of our Doulat Public School Purulia celebrated Independence Day at the school premises. At 10 A.M., hosting of the National Flag marked the beginning of celebration. On this occasion, students of the school put up a

spectacular concert. In addition to hosting this concert, students of the school participated in a walk in the locality.

Up there at our residential home in Matigara – Siliguri, the residents hosted the National Flag at 9 A.M. This was followed by a day packed with fun-filled activities. The celebration ended with lowering of the flag a while

In Kolkata, students of our Non-Formal school at Bashanti Colony, adjacent to Bidhan Nagar Railway Station, unfolded the national flag at the school premises around 10:30 in the morning. This was followed by a dance drama presentation by the students themselves, depicting the sacrifices of our heroes in the long struggle of India's independence.

White Cane Safety Day, 15th October, 2018.



Turnstone Global in association with Amway Opportunity Foundation observed the White Cane Safety Day. A week long awareness campaign were launched in different schools of Kolkata. Purpose was to make our tomorrow's citizens aware about difficulties of the visually challenged in their daily lives. The children were also provided inputs about how they can extend their cooperation towards a blind person if they encounter any such person, be it on the road or elsewhere. Various gaming activities were also organised among the school children, which were much appreciated by them.

Swarasati Puja celebrated with grandeur at all of our educational centres




